**STUDENT STATEMENT OF RESPONSIBILITY**

For and in consideration of the benefit provided me in the form of learning experience (Program) with the Clark County School District (hereafter "DISTRICT"), under the Educational Affiliation Agreement (the "Agreement") between the Board of Regents of the Nevada System of Higher Education, on behalf of the University of Nevada, Las Vegas, College of Southern Nevada, and Nevada State College ("INSTITUTION") and DISTRICT, I, \_\_\_\_\_, a student at the University of Nevada, Las Vegas, on my own behalf and on behalf of my heirs, assigns and personal representative (if deceased), do hereby covenant and agree to assume all risks and be solely responsible for any injury or loss (including death) sustained by me while participating in the Program operated by INSTITUTION at DISTRICT, unless such injury or loss (including death) arises solely out of the negligence or willful misconduct of DISTRICT or INSTITUTION or their respective directors, officers, employees, or agents.

I will abide by INSTITUTION and DISTRICT's Code of Conduct and all of INSTITUTION and DISTRICT's policies, procedures, rules and regulations throughout the learning experience with DISTRICT. I will notify both INSTITUTION and designated DISTRICT representative (liaison) if, for any reason, I am unable to report to DISTRICT for a scheduled rotation or to participate in the Program.

I acknowledge and further agree that neither INSTITUTION nor DISTRICT is responsible for carrying medical or accident insurance for my participation in the learning experience with DISTRICT.

I acknowledge and agree that any medical treatment whatsoever that may be required during my participation under this Agreement or arising out of my participation will be solely my financial responsibility.

I also agree that I am solely responsible for my maintenance, support and living expenses and transportation to and from DISTRICT premises throughout the period of my learning experience with DISTRICT.

I hereby acknowledge and agree that the State of Nevada, including its Board of Regents of the Nevada System of Higher Education, INSTITUTION, DISTRICT, and their respective directors, officers, employees and agents (in their individual and official capacities) will not defend, indemnify or otherwise compensate and/or reimburse me for any acts or omissions committed by me which are found to be outside the scope of the learning experience with DISTRICT.

I understand and agree that my status with DISTRICT throughout the period of my learning experience with DISTRICT is that of a student receiving education. For this reason, I can have no expectation of receiving compensation from, or future employment with, either DISTRICT or INSTITUTION. Additionally, for this reason, I understand and agree that workers' compensation by INSTITUTION or the DISTRICT does not apply.

I hereby acknowledge and agree that I have been offered the opportunity (if desired) to consult with my own attorney concerning the contents of this Student Statement of Responsibility before signing it.

I warrant that I am at least 18 years of age; that I have read and understand the contents of this document; and that I sign it freely and without reliance upon any representations or promises by the State of Nevada, including its Board of Regents of the Nevada System of Higher Education, INSTITUTION, DISTRICT or their respective directors, officers, employees or agents.
